WEBINAR OVERVIEW

Furthermore, we will spotlight exemplary case practices from Poland, featuring contributions from <u>Experyment Science Centre</u> and the <u>Institute of Animal Reproduction and Food Research</u> of PAS, both involved in activities of <u>SPiN</u> – Society and Science Association. These case studies will present diverse applications of Citizen Science across different domains and the valuable contributions made by Polish stakeholders to the global Citizen Science community.

The webinar will culminate in a session delivered by an expert from <u>Polish National Contact Point</u> (NCP) for Horizon Europe. This part will provide participants with tangible guidance and resources for incorporating Citizen Science approaches into their research projects, fostering collaboration and cocreation between researchers and citizens with Work Programmes 2025 of Horizon Europe.

GENERAL REMARKS

The primary objective of the activities conducted within the PolSCA Webinar series is to enhance understanding of the European Union framework programme for research and innovation – <u>Horizon</u> <u>Europe</u> (HE) among representatives of the scientific community at the <u>Polish Academy of Sciences</u> (PAS). Participation in Horizon Europe (2021-2027) will undoubtedly pose significant challenges for scientists and research units in Poland, including PAS Institute employees. However, the Horizon Europe programme, with a budget of EUR 95.5 billion, presents a substantial opportunity to undertake ambitious R&D projects, primarily through extensive multilateral scientific cooperation.

The synergy of various activities initiated within the **PASIFIC programme** under the auspices of PAS headquarters, combined with dissemination and training efforts conducted by the **PoISCA Office** in alignment with its mission, is expected to contribute to enhancing the effective participation of PAS research institutes in projects funded under Horizon Europe. To further facilitate this, PoISCA is actively engaged in establishing and reinforcing an informal support network tailored to scientists and research managers from PAS institutes within the framework of the EU research and innovation programme, with a particular emphasis on Horizon Europe.
